We can enter the grounds at 9:30 AM, BUT NOT EARLIER. The gate may be locked, or may not be if there is any skeet shooting going on. Chapter members and their guests are asked to NOT ENTER the property until 9:30 per request of the Club manager. Coffee etc. will be available throughout the morning while the MART is being held outdoors in the parking area. The clubhouse will be used for our Show and Tell activity, as well as the door prize giveaways and lunch, as available.
